5. FAI

5.1. Report of the FAI Secretary General

Refer to Annexe 5 and Markus Haggeney's presentation.

Questions:

Michel Sigel: It is difficult to follow and understand. Could the Secretary General provide to Plenary delegates earlier next year?

Marcus Haggeney: This report is basically compiled to give the "tone" of progress of the Secretariat. It has been given to all NACs previously for information purposes.

Andy Shaw: the report suggests that sponsorship revenue is down; what is the current situation? Marcus Haggeney: Past major agreements i have been discontinued and previous main financial support has been lost. The FAI is currently looking at a multi-year agreement where the FAI should be back on a healthy track.

David Monk: We have to be careful with the offers that have been received to ensure that each is beneficial both ways.

5.2. Welcome from the FAI President

David Monk complimented CIVL's progressive use of IT that allowed the Plenary to be so well attended. He explained that there had been positive changes within the FAI.

Governance and financial issues and trust have improved within the various organisations of the FAI.

The last time the FAI had achieved the budget was in the 2015 financial figures. Further he understood that 2021 will be the same and gave credit to the Secretariat.

Financial processes have necessarily improved and are now in-line with an external report's recommendations commissioned three years ago.

The lack of procedures in many areas is a weakness that is being addressed Stephane Malbos: Yes, trust has improved and we now have a two-way street of communications. Delegates should look at Annexe 6B that shows the Commission Presidents' Group history and present work. They show that we are all now working *together*.

Questions:

Concern was voiced about reducing the maximum number of pilots.

Martin Jovanoski: Choosing the right number of pilots is a responsibility shared by the organiser and the Bureau. This number is published in the local regulations.

Andy Shaw: The PGA Committee has to be more efficient in finalising its work so it can move forward.

16. Report from the Paragliding Aerobatic Committee

Refer to Annexe 16 and Claudio Cattaneo's presentation.

Stephane Malbos: Whilst Aerobatics concerns only few pilots, it is highly visible and provides the best advertising of CIVL airsport to the public and potential sponsors.

Claudio Cattaneo: Synchro is very difficult to show as competitors prioritise their individual ambitions. They do not have the time to train; appropriate facilities are hard to find.

Details are given on the next possible Judging training in Guatemala.

An informal South/Central America Zoom/WhatsApp group will be formed.

17. Report on Safety

Refer to Annexe 17 and Mitch Shipley's presentation.

From Q&A we learnt that:

Minor and major injury depends on whether there is hospitalisation or not.

There is currently no breakdown between HG and PG for launch and landing incidents.

The one fatality is studied. The discussion concerns the obligation of having two reserves and the need to control this or not during event. The discussion is cut short by the president as open meetings, not the plenary, are the place to do it.

Third-party insurance and liability should cover officials. (It should be as per the organisers' agreement.)

18. Report from the Software Officers

19. Report from the Records & Badges Officer

No significant activity to be reported

Igor Eržen: The FAI secretariat is responsible for verifying the records.

Stephane Malbos: A process is being studied so verification is done by the commission. The International Skydiving Commission (ISC) is leading the project.

Marcus Haggeney: At some point in 2021, there was a major backlog due to understaffing of the secretariat. We are back to normal. The Sporting Codes requirements sometimes cause complexity of verification.

20. Report from the Competition Coordinator

Stephane Malbos explained how issues with Cat 2 events are treated, until a Bureau decision finalises the process.

21. Report from the Jury & Steward Coordinator

Jamie Shelden: The published list is subject to adjustments.

Stephane Malbos explains the new Bureau policy to make sure that each Cat 1 gets media coverage on our website. It may involve local contacts and/or the physical presence of Elena. Bill Hughes: A nominal amount (€2.5k) has been budgeted to that effect.

23. Proposals from the CIVL Bureau

23.1. Fairness in XC Team events. Refer - Annexe 23a.

S7 Common – 2.5.2 Individual Entry

Replace...

Current World and Continental Champions, male and female, and for paragliding XC competitions the top 5 women in the WPRS ranking, shall be allowed a discretionary entry to defend their title if not selected as part of the national entry, providing they have NAC approval. But they shall not score for their national team.

With...

In Paragliding Accuracy and Aerobatic, current World and Continental Champions shall be allowed a discretionary entry to defend their title if not selected as part of the national entry, providing they have NAC approval. But they shall not score for their national team.

The discussion was extensive and took place in many venues.

Following it, the Bureau withdrew its proposal and replaced it with:

The rule is adjusted so Defending Champions plus Top 5 Women combined extra spots are limited to only one extra spot to any nation.

Section 7a modified accordingly.

There are obvious issues with women and team representation in World PG XC events.

The Bureau will open a discussion on the matter. All solutions will be explored, including standalone Women and Team championships. The discussion may conclude with proposals to the 2023 plenary.

23.2. Paragliding XC World Events. Annexe 23 b.

Separate championship for Women

The proposal was withdrawn.

We are not ready at the moment and further discussion is required. It is underlined that the possibility to organise specific Women PG XC championships exists within the current rule. All that is needed is a bid and a plenary that accepts it.

23.3. Full Allocation Rounds Only

The proposal was withdrawn.

The consequences of the proposal need to be reviewed further. The overall allocation process is to be also reviewed.

23.4. Gender-neutral rules. Annexe 23c.

CIVL is to adopt a gender-neutral policy for its communication and documentation and make use of gender-inclusive language as far as possible. Section 7 will be modified to make it gender-neutral. These modifications will be considered as a cleaning-up exercise. The gender-neutral versions of Section 7 will be approved by the CIVL Bureau.

It was noted that this is a clean-up only.

No vote required.

The project will be moved forward.

23.5. Mandatory EMS. Annexe 23d.

It was agreed that the implementation of the API in the EMS will be done in consultation with all concerned parties. CIVL wishes to make a system that works for everyone, including the addressing of sporting licence issues and all Cat 2 events.

The proposal staved unchanged.

Date of implementation to be: March 1, 2022.

Add in Section 7 Common 2.5 General Event Organisation

2.5.16 Event Managing System 2.5.16 Event Management System

Full use of the CIVL Event Management System is recommended, but not mandatory. In First Category events and test events, it is mandatory to use the CIVL Event Management System for registration, allocation, publication of all documents and results. CIVL reserves the right to require and/or use other EMS functionalities, including media-orientated features.

For all events

It is mandatory for all first time Second Category event pilots to register in civlcomps.org so they can get a CIVL ID.

Pilots must take extra care to fill all information correctly. Pilots who have not registered correctly in civlcomps.org will not be processed in the ranking of the event.

Organisers must make sure that the CIVL ID are correct at registration time and when sending the results.

23.6. Allocation deadlines. Annexe 23e.

The original proposal was amended as follows: 14 days instead of 7 days.

Section 7a, b and c specify that allocation must be finalised 60 days before the start of the championship. The current texts are to be replaced by:

The allocation process takes part between three and two months before the start of the event. The local regulations shall state the precise deadlines.

After the two-month deadline, available spots may be allocated following the general principle of allocation until 14 days before the start of the event.

Between the 14-day deadline and the first pilots' briefing of the first task/round/run, only a missing pilot from a nation can be replaced by another one from the same nation.

27. Proposals from the Paragliding Accuracy Committee

Judges Code to be removed from Section 7 (Annexe 27)

It is proposed that the Judges Code be removed from S7C (other than obligatory SC7C requirements like nation representation in Cat 1 events, etc.) and compiled as a free-standing document into the Paragliding / Documents / Officials / Judges section, together with the other judging documentation.

28.2. Minimum representation (Annexe 28 b)

Proposal to add to Section 7 Common 2.5.5. Minimum representation

In all disciplines, the minimum representation in Continental events is not 3 countries with a at least 8 competitors, but 4 countries with at least 8 competitors.

For Aerobatics a minimum of 4 countries with a at least 5 competitors is required.

The two proposalswerenot clearly explained and voted on.

The CIVL Bureau, after consultation with the delegate, will take a decision to approve it or not. The Bureau decision will have to be approved by the 2023 plenary.

29. Proposals from the Safety Officers

None received.

30. Proposals from the Software Working Group

Section 7F Change definition of task distance: Annexe 30.

With the proposed change, pilots may choose a different point to touch the ESS cylinder than the one suggested by route optimisation, resulting in them flying a longer distance than the calculated task distance.

In general, it is accepted that pilots fly further than the task distance to complete a task. On the other hand, a pilot flying less than the task distance, and still completing the task appears to be wrong. But with the current definition of task distance, that will be possible.

With the proposed change, that possibility is removed.

Refer to the Annexe for details.

Section 7F modifications: Annexe 31.

Tracklog recording interval is to be lowered from 5seconds to 1second.

It was noted that the recording interval in Section 7d and 7f is stated in several places: They will be adjusted accordingly.

33.1. Switzerland - Creation of a Cat 1 PG XC championship for Junior (Annexe 33a)

Section 7 Common is modified as follows:

2.2.1 Categories

First and Second Category events may take part in the following categories: Individual, Team Overall, Men, Women, Junior.

. . .

Vote - 2/3 qualified majority

33.2. Germany - Tolerance in all radius calculation, including CTR (Annexe 33 b)

The proposal was withdrawn.

A Working Group comprising manufacturers and CIVL representatives is to be formed to define a standard for distance calculation to the restricted airspace. There will be no tolerance. No vote needed.

33.3. Germany - Airworthiness standards for harnesses (Annexe 33 b)

The proposal was withdrawn. It is to be replaced by the following:

Section 7a

8.5.1 Harnesses

To participate in First Category events, a harness and back protector combination must have been certified to LTF09 or EN1651:2018 or after, more than 90 days before the start of the event. CIVL publishes an indicative list on its website.

33.4. France - Airspace declaration in records (Annexe 33c)

The proposal is amended by France as follows:

Section 7d 7.1 Soaring Task declaration form

Add an "Airspace List" at the end of the document so pilots can fulfil it at declaration.

I certify that the entire flight was made without violating any applicable restricted airspace, except as detailed below (if applicable)

33.5. Bulgaria - Maximum number of pilots in PG XC Cat 1 (Annexe 33 d)

33.7. Slovenia - Cloud Flying (Annexe 33f)

Section 7a 6.3.1 Cloud Flying

Cloud flying is prohibited and it is unsporting to gain an advantage by flying in cloud, and unsafe to fly in cloud because visual references are lost and it is impossible to maintain a safe separation from other pilots.

Cloud flying is defined as any part of the glider or the pilot disappearing from the view of observers or pilots close to him or her.

Pilots who climb too close to an active cloud in a strong thermal to the extent that they are not able to control their altitude may also be deemed to be cloud flying.

Since it is against the law to climb up the side of a cloud above the transition level, this may not be an acceptable excuse for being higher than other pilots in the case of a complaint. It is the responsibility of the competitors to report cloud flying to the MD or the TD

If a pilot is inadvertently sucked into cloud, the onus is on that pilot to demonstrate that no advantage was gained. A pilot's tracklogs will be checked to determine whether advantage was gained by cloud flying whenever:

- They are observed by a competition official or air marshal going into cloud and completely disappearing from view or,
- At least 2 pilots witness the accused going up into cloud and disappearing from view and taking advantage from this action or,
- The Meet Director at his discretion reviews track log data that appears to show advantage being taken by cloud flying.

6.3 Specific Penalties

Cloud flying.

1st offence: 10 points 2nd offence: formula below

$$Pts_{penalty} = 1000 * min \left(1, \frac{1 - 1.05^{depth}}{1 - 1.05^f} \right)$$

f = 100:

• The penalty reaches 1000 points when depth ≥ 100m.

3rdoffence: expelled from the competition.

39.1. CIVL transgender policy.

Currently, as per Plenary 2017 who approved a Bureau decision: pilots are of the gender shown on their national identification papers.

The plenary confirms this policy and will adjust Section 7 Common new 2.2.1 accordingly. No vote needed.

39.2. CIVL Strategy Working Group

CIVL has many long-term objectives that require ongoing work to accomplish. Currently, the way CIVL functions, members get together once or twice a year to have concentrated discussions and vote on matters, but in between, progress is often maintained only by sporadic comments and discussions on Basecamp.

The CIVL bureau could continue work on CIVL strategy on its own, but would like to create an expanded working group to take advantage of the skills and expertise of some of the members of the community.

The Bureau therefore intends to create such a working group and will allocate some funds (evaluated at €3k) for members of the WG to possibly get together for an in-person meeting during the year.

The first step of the working group will be to create its charter and expected deliverables, and present this to the CIVL Bureau. Once the WG plan is approved by the Bureau, the working group will work virtually to progress and present periodic status to the CIVL Bureau.

39.3. Class 5 Eligibility Clarification

2.1.3 In the 36 months before the ranking reference date, which is 3 calendar months before the championship starts, a pilot has to have:

Been ranked with at least 20 WPRS points in Hang Gliding Class 1.

Participated in one or more FAI sanctioned competitions with at least 30 pilots.

To be replaced by:

In the 36 months before the ranking reference date, which is 3 calendar months before the championship starts, a pilot has to have:

Been ranked with at least 20 WPRS points in Hang Gliding Class 1.

Participated in one or more FAI sanctioned competitions with at least 30 pilots in any class or combination of classes.

No vote needed.

39.4. Aerobatic Judges Seminar

Claudio Cattaneo underlines that the next judges' seminar in Guatemala may be restricted by the country's requirement to only allow people with full vaccination to enter the country. This is a problem for international travellers.

39.5. PG XC Scoring

Goran Dimikovski reminds that the CIVL is looking at other XC scoring system. The one developed by Daniel Dimov and Yassen Savov will be tested, with the CIVL financial support during a 21–27 August, 2022 event. There will be another event, not sponsored by CIVL, during 4–10 July.

39.6. CIVL President closing remarks

Stephane Malbos thanked all for their attendance and support. He asked for feedback on whether the Zoom facility of holding the Plenary was acceptable.

The Strategy Working Group and maybe a specific Working Group dedicated to PG XC Cat 1 will be formed ASAP.
